# What is The Jefferson County Memorial Project?

#### THE NATIONAL MEMORIAL FOR PEACE AND JUSTICE

The Jefferson County Memorial Project (JCMP) was created after the Equal Justice Initiative (EJI) opened the National Memorial for Peace and Justice, a groundbreaking memorial in Montgomery dedicated to African American victims of racial terror violence. The Memorial contains monuments corresponding to over 800 counties where EJI documented racial terror lynchings. EJI has invited these counties to host community remembrance efforts around soil collection, historical markers, and the retrieval of their monument to engage communities in local reckonings.

#### THE JEFFERSON COUNTY MEMORIAL PROJECT

JCMP is a coalition with a four-pronged mission of memorializing victims of racial terror violence and expanding our county's understanding of past and present issues of racial injustice. We're proud of the strategic and intentional work that we do with over 40 community partners.

- Research and reach out to descendants of the victims of the 33 Jefferson County lynchings.
- Educate the county on the history and purpose of the monument through museum exhibits, K-12 engagement, a city-wide book discussion, and other programming.
- Place the monument and establish historical markers throughout the county.
- Advocate for criminal justice reform for the city and county.

# What is JCMP Fellowship?

In 2023, the JCMP Fellowship Program presents local college juniors, seniors, and graduate students with the opportunity to take part in a historic initiative with The Jefferson County District Attorney's Office. JCMP fellows have the rare chance to serve as integral partners in the Emmett Till Cold Case Project, supporting the JCDA's efforts through an expanded historical exploration of cases of civil rights violations. They will be a part of our coalition, helping the community heal while educating the public on the importance of that history. Specifically, JCMP is providing support from the initial investigative period through the end of the grant project by engaging our fellows and developing resources for community conversations surrounding the purpose of this project.

During the summer semester, working with a mentor, JCMP Fellows will learn how to become trauma-informed discussion leaders and conduct primary and genealogical research. ## **Helpful Details**

#### **ELGIBILITY**

Applications are accepted from juniors, seniors, and graduate students attending the following schools: Birmingham–Southern College, Jefferson State Community College, Lawson State Community College, Miles College, Samford University, and the University of Alabama at Birmingham. No prior research experience is necessary to participate. **We welcome applications from students across all majors and disciplines!** 

#### **TIMELINE**

Students are expected to dedicate 2-4 hours a week to research and must attend a meeting one Thursday of every month. Outreach and planning will be the focus of the summer semester. The fall semester will be dedicated to research. In July, we will host a weekend-long retreat for the fellows to prepare for advocacy initiatives.

#### **FINANCIAL STIPEND**

All Fellows are eligible for a \$750 financial stipend per semester for their participation in the fellowship.
